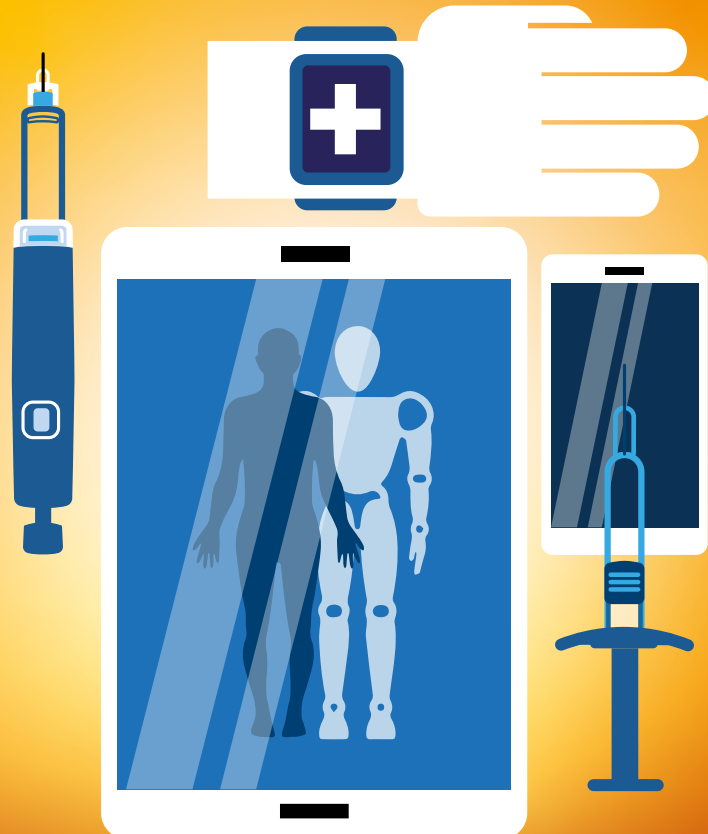

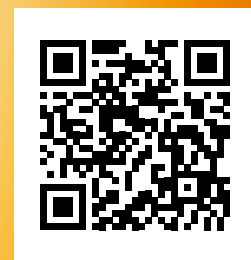
Additional on-site presenters are required to pay the conference registration fee.
